  - b) What plans does the County Government have to ensure that this function of the County Government is implemented?(**Hon. Hanifa Badi – Nominated MCA** )
- Aware that section 7(1)(b) of Persons with Disabilities Act provides for the functions of the national Council for Persons with Disabilities to include to formulate and develop measure and policies design to achieve equal opportunities for Persons with Disabilities by ensuring to the maximum extent possible that they obtain education and employment, participate fully in sporting, recreational and cultural activities that are afforded full access to community and social services, further aware that, Section 15 of the Act states that no employer shall discriminate against a person with disability in relation to the advertisement of employment, the recruitment of employment , the creation, classification or abolition of posts, concerned that in Kwale County since the inception of devolution the number of persons with disability employees is very low;
  - a) Has the County Government implemented Section13 of the persons with disabilities on the employment process?
  - b) Does the County have a plan to address lack of transportation means that is a barrier to work for persons with disabilities?
  - c) What is the County Government doing to ensure that persons with disability work in an adoptable environment?(**Hon. Mishi Mayumbe– Nominated MCA** )
