# THE KWALE COUNTY SUPPLEMENTARY APPROPRIATION (NO. 3) ACT, 2022

### No. 2 of 2022

Date of Assent: 22nd June, 2022

Date of Commencement: 28th June, 2022

AN ACT of the County Assembly of Kwale to authorize the issue of a sum of money out of the County Revenue Fund and its application towards the services of the year ending on the 30th June, 2022 and to appropriate that sum and a sum voted on account by the County Assembly for certain public services and purposes

ENACTED by the County Assembly of Kwale, as follows-

#### Short title

1. This Act may be cited as the Kwale County Supplementary Appropriation (No. 3) Act, 2022.

Issue of the sum of KSh.12,765,640,172 out of the County Revenue Fund and apply towards the supply granted for the service of the year ending on the 30th June, 2022

2. The County Treasury may issue out of the County Revenue Fund and apply towards the supply granted for the service of the year ending on the 30th June, 2022, the sum of Kenya Shillings Twelve Billion, Seven Hundred and Sixty-Five Million, Six Hundred Forty Thousand, One Hundred and Seventy-Two only and that sum shall be deemed to have been appropriated as from 1st July, 2021.


### Appropriation of the Sum granted

- 3. The sum granted by section 2 shall be appropriated for the several services and purpose specified in the second column of the Schedule in the amounts specified in the third column of the Schedule.
- (2) The sum granted out of the County Revenue Fund by section (2) includes the sum of **Kenya Shillings Twelve Billion**, **Seven Hundred and Sixty-Five Million**, **Six Hundred Forty Thousand**, **One Hundred and Seventy-Two only** authorized by the County Assembly on the 22nd June, 2022 in accordance with Article 224 of the Constitution, 2010.
- **4.** The supply granted for the services of the year ending on 30th June, 2022 in respect of votes 3061, 3062, 3063, 3064, 3065, 3066, 3067, 3068, 3069, 3070, 3071, 3072, 3073, 3074, 3075 and 3076 in accordance with the Kwale County Appropriation Act, 2021.
